Line Spacing: single space; Alignment: Justified; Orientation: portrait; Page size: A4
Preparation of Text-Title: Pre14pt, bold and cantered, name and surname, academic title, affiliation and e-mail

Abstract: 150-250 words using Arial Narrow 10pt italic font; max. 5 keywords- bold; leave two empty lines 4 between the abstract and main text

Subdivision of the article: 2000-5000 words, each title, and subtitle section should be numbered; 12pt, justified, abstract not included in section numbering. Leave one empty line between each title and the main text. Include pictures in the text.

References: References should follow the references style used by the American Psychological Association (APA) in alphabetical order (www.apastyle.org/manual/index.aspx). Only in-text citations should be included in the References section. e.g., Kidder, T. (1981). The soul of a new machine. Boston, MA: Little, Brown & Company.

Basis for Abstract Acceptance

The basis for acceptance of papers is that they are relevant and contribute to the current literature using the Structured Abstract template below. Authors are invited to submit an extended abstract of 150-250 words or less to the conference chairs. All conference abstracts will be reviewed by members of a Scientific Committee to ensure their academic rigor, practical significance to the industry, and value to existing literature. Each abstract should have a separate title page that includes the title of the paper, author name(s), affiliation(s), and full contact details including address, fax, phone, and e-mail. Your abstract must include up to five keywords that capture the contents of the paper. Submit your abstract (maximum 250 words), choosing from the presentation formats listed below (Oral, Poster, Panel, Conference). Your abstract will undergo peer review and the results will be returned to you by January 30, 2023.

Follow the Template for Writing a Structured Abstract

Research problem/purpose: Summarize your purpose and rationale (1 to 2 sentences)

Literature review: Identify the bodies of literature you consulted and summarize the key points of the review (1 to 2 sentences)

Methodology: Identify your study as qualitative, quantitative, critical, or mixed methodology. Describe how you chose participants and how many you used. Describe how you chose your location and its type. Identify your method of data collection. Name your analysis techniques.

Results and Conclusions: Summarize your answers to the research questions; summarize the implications of your results (1 sentence); Summarize the limitations of your study (1 sentence); Summarize your suggested future research (1 sentence).

Practical Implication: Clearly state any implications for research, practice, and/or society (1 sentence).

Originality: Clearly state the new and significant information adequate to justify publication (1 sentence). **Paper Type:** Research, **Keywords:** At most 5 words.
